

## Data Protection Statement

The Gaelic Players Association fully respects your right to privacy, and will not collect any personal information about you without your permission.

**Members' Information sought:** Players' name, address and contact details, county and code played, bank details, expenses (mileage & nutrition) claimed.

As part of the annual GPA survey (a) general well-being questions (b) player opinions on GPA policy (c) measurement of satisfaction with GPA (d) Specific medical/ health research on incidence of hip/groin injuries

**Why we need this information** - We will require your contact details and some other personal information in order to offer the benefits and services which you would expect by being a member of this organisation. This also helps us to predict future trends in demand for services.

Information that is gathered for use in any injury/medical survey will be anonymised.

**Third Party Service Providers** - The GPA will not disclose your data to any third party without your express permission. When your data is being transferred to a third party Player ID numbers only will be used. Only data that is required by the Third Party Service Provider (TPSP) will be shared. All of our TPSPs have signed a Data Processor contract and are bound by this agreement to keep your data confidential and secure.

If it is required that the GPA must transfer to any TPSP, medical/ health data pertaining to any member, explicit permission will be sought from that member. And appropriate safeguards put in place to secure that data.

Please note that there are however, certain situations, including the prevention and detection of a crime, or if there is genuine concern for your own or others health and safety (among other restrictions outlined in GDPR Article 23 (1)) where the GPA will be obliged to share your information, if requested with certain statutory organisations.

**Data storage** - Your personal data will be stored on the GPA secure management system for a period of 6 years after you cease to be a member of the GPA. After that time, you will be contacted to confirm that you no longer wish to be a member and at that time your information will be anonymised.

**Rectification** - Any member has the right to have any incorrect or incomplete data held by the GPA corrected or completed with no undue delay.

**Right to be Forgotten** – members and former members have the right to have their information erased from the GPA member management system should they no longer wish to be a member of the organisation (GDPR Article 17(1))

**GPA membership** – please note that the completion of this form and the provision of this personal data is part of your application for your Government Grant payment, which ensures you become a GPA member. If you do not wish to submit any personal data nor become a member of the GPA but still wish to claim your grant you can call the GPA office on 01 6520271

Any personal information on members which is provided to the GPA, its staff or service providers will be treated with the highest standards of security and confidentiality, strictly in accordance with the Irish Data Protection Acts, 1988 & 2003 and GDPR regulations 2018
