INFORMATION FOR EMPLOYEES

❖ **Employees and Self-employed Covid-19 Pandemic Unemployment Payment**

If you have lost your job due to Covid-19 you can apply for the Covid-19 Pandemic Unemployment Payment.

The payment has a one-page application form and will be paid for a period of 6 weeks at a flat rate payment. It is designed to deliver a social welfare payment to the unemployed and provide income security during the pandemic.

COVID-19 Pandemic Unemployment Payment Application Form

You can apply for this payment if you are an employee or self-employed.

The quickest way to apply for this payment is to apply through [mywelfare.ie](https://www.gov.ie/en/service/be74d3-covid-19-pandemic-unemployment-payment/).

❖ Covid-19 Enhanced Illness Benefit

If you have been diagnosed with Covid-19 or are medically certified to self-isolate as a result of Covid-19, you can apply for Illness Benefit for Covid-19 absences.

When a worker is told to self-isolate by a doctor or has been diagnosed with COVID-19 (Coronavirus) by a doctor, they can apply for an enhanced Illness Benefit payment of €350 per week.

To be eligible for this payment a person **must** be confined to their home or a medical facility.

You can apply for this payment if you are an employee or self-employed.

❖ Employees who are laid off temporarily or put on to short time working (Covid-19)

Employees who are laid off temporarily, without pay, due to a reduction in business activity, can apply for a [COVID-19 Pandemic Unemployment Payment](#).

❖ **If you are a student who has lost your job**

If you are a student who has lost your job due to the COVID-19 pandemic, you can apply for the [COVID-19 Pandemic Unemployment Payment](#).

Depending on your means, you may also be entitled to [Supplementary Welfare Allowance \(SWA\) Supplements](#)

If you are a full-time student with a part-time job in the evenings or at weekends, you can get the Pandemic Unemployment Payment as you have lost work. But you cannot get a regular jobseeker's payment as you are not looking and available for full-time work.

❖ **If you are a casual worker on Xs and Os during COVID-19 (Coronavirus)**

If you are a casual worker who submits docketts for the days you are employed, you should continue to do so if you are still working.

If you are not working because of COVID-19, you should inform your local Intreo Centre that you are out of work – and you will get the full rate of jobseeker's payment.

You should not apply for any new payment during the COVID-19 pandemic.
